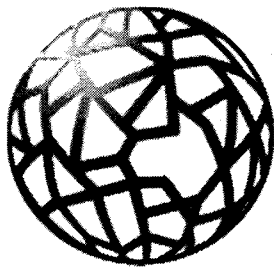

STATEMENT OF SURF AID INTERNATIONAL AUSTRALIA LIMITED'S GOALS OR PURPOSES

Our Mission

The mission of Surf Aid International Australia Limited, a non-profit humanitarian organisation, is to improve the health, wellbeing and self-reliance of people living in isolated regions connected to us through surfing.

SUMMARY OF OVERALL PROGRAM ACTIVITIES AND NAMES

SURF AID INTERNATIONAL AUSTRALIA LIMITED ("Surf Aid") www.surfaid.org

Surf Aid implements mother and child health programs, including water and sanitation projects, and emergency relief in the Mentawai and Nias islands off the western coast of Sumatra, and Sumba and Sumbawa in eastern Indonesia. These are culturally and geographically isolated regions where nutrition is generally poor and the people suffer from a high prevalence of treatable and preventable diseases.

BACKGROUND

Founded in 2000 by a small volunteer group of surfers in New Zealand, Surf Aid has grown into fully international organisation and has strong support in Australia, New Zealand and the United States. In 2014 Surf Aid merged with Sumba Foundation Australia, with a full mother and child health project commencing in Sumba in 2015.

The growth of Surf Aid has been strongly impacted by natural disasters. Prior to the 2004 Asian Tsunami, Surf Aid's resources were limited and focused on a malaria control program. As the only frontline humanitarian organisation operating in the region at the time of the tsunami, Surf Aid mounted an emergency response that was largely funded by the Australian and New Zealand Governments, and the surfing industry. Surf Aid was also at the frontline of the Nias earthquake three months later in 2005. Following the success of those responses, Surf Aid broadened its program and continues to respond to natural disasters, the most recent being the September 2009 earthquake in Padang, the October 2010 earthquake and tsunami in the Mentawai Islands and 2016 floods in Bima, Sumbawa.

For the past thirteen years Surf Aid has been delivering development programs focused on mother and child health (MCH) and emergency preparedness in remote areas of Indonesia that are connected to us through surfing.

PROGRAM LINEUP

Surf Aid supports those people living in isolated regions and remote areas, who are often forgotten. Often they can't access basic public services, either because there are no services, or because they are too far away. Also the quality of available services are often far below national standards. This directly results in unnecessary deaths, especially among pregnant women and children under five. It also contributes to current unacceptably high levels of malnutrition, diarrhoea and acute respiratory infections in children under five. Delivering services in remote areas is costly, time-consuming and requires serious effort.

Surf Aid's current projects are focused on mother and child health and initiatives to sustain MCH activities. The main targets for the mother and child health promotion program are mothers and pregnant women. In the design of the programmes we put mothers at the centre as the main actors to be influenced for behaviour change. We recognise that many factors, people and institutions influence mothers. Surf Aid believes that MCH can only be improved if basic health structures are in place and adequately equipped; if staff and volunteers are well trained, able and motivated to deliver appropriate health services; if mothers and caregivers understand and practise healthy behaviours and there is a positive environment to support and foster improved health behaviours. Therefore, we create interventions for all these different actors and institutions, to ensure the right environment is created to support MCH, and barriers to change are removed. Barriers to change include: a lack of access to clean water, limited access to nutritious foods, a lack of confidence in the existing health systems and the lack of a supporting environment.

Following the Indonesian national strategy and existing structures, the natural entry point for intervention is the Posyandu and the community health volunteers (kader). Each sub-district has a basic public health centre (Puskesmas) that employs medically trained health professionals. Staff travel monthly to communities to deliver Posyandu services and are assisted by the kaders. Posyandu focuses on health issues relating to mothers, children and pregnant women. The quality of Posyandu services varies greatly. There is a direct correlation between poor Posyandu services and high levels of isolation and poverty. At the start of our work in each of our project sites the Posyandu services were of poor quality.

In summary, our MCH programmes include a mix of training and practical support to strengthen community knowledge and achieve positive behavioural change across the community.

- Partnering with communities to construct safe water facilities, and providing education on sanitation, increased the use of clean water and correct sanitation practices.
- Posyandu are now equipped with appropriate equipment, and kader and health professionals have now been trained to increase their knowledge around translating national strategies into locally relevant healthy living practices. Once this has been achieved, volunteer groups are trained in income generation to support continual improvement in the posyandu service.

Currently, we have Mother and Child health or successor livelihoods and nutrition programs in-

Nias – EHOWU2, Enhance Health of Women and Children Under five. EHOWU is a word from the local Nias language. No one exact translation covers it, but it can be described as a seed that grows and develops, benefits, or has advantage for the community from generation to generation. It also resonates with 'Yahowu', the local greeting.

Mentawai – Katuerukat - Resilient families through community based economic development Keluarga Tangguh dengan Usaha Ekonomi Rakyat Untuk Kesejahteraan masyarakat Katuerukat means Prosperous, in the Mentawai language.

Sumbawa - SIMBO - means growing into a bigger shape; become bigger, or developing.

Mbojo is a word in the Bima language, meaning Bima people. So Simbo means: Healthy mothers and Children in Bima!

In March 2015 we commenced in **Sumba** with **HAWUNA** - Hidup sehAt dan Wahana Usaha maNdiri di laboyA barat. Hawuna means to come together, one-ness, working together for a purpose in the Gaura / West Sumba Language. This captures the program's focus on healthy living and opportunities for self reliance in Laboya Barat.

These projects all have clean water and nutrition components. We completed a three year Emergency Preparedness project in the islands west of Sumatra in May 2014. In 2016 we completed a four year long-term recovery project with the communities most impacted by the 2010 tsunami.

CEO's Message

Surf Aid supports people in isolated regions connected to us through surfing, currently in four island locations in Indonesia, 2016-17 saw our greatest successes yet with our mother and child health projects. Our delivery model for MCH in remote areas of Indonesia has now been proven in three locations across the archipelago. Projects in Nias, Mentawai and Sumbawa have been successfully delivered, with our Sumba project on track in its third year.

In the April 2016 to March 2017 year Surf Aid, working with our partner communities; trained 1706 people, built or improved 306 water facilities and measurably improved community health services in 68 villages. These results are a massive tribute to the villagers who are striving to improve their children's lives, our staff who live with them to trigger changes in behaviour, and the belief and support of our donors and ambassadors.

DISCUSSION AND ANALYSIS OF THE 2017 FINANCIAL STATEMENTS

The concise financial statements are an extract from the full financial statements for the year ended 31 March 2017 which are available on the website. The financial statements and disclosures in the concise financial statements have been derived from the 2017 financial statements of Surf Aid International Australia Limited. A copy of the full financial statements and auditor's report will be sent to any member, free of charge, upon request.

The concise financial statements cannot be expected to provide as full an understanding of the financial performance, financial position, financing and investing activities of Surf Aid International Australia Limited as the full financial statements.

The discussion and analysis is provided to assist members in understanding the concise financial statements. The discussion and analysis is based on the Surf Aid International Australia Limited financial statements.

Statement of Comprehensive Income

The net surplus before income tax for the year was \$10,365 being a decrease of \$24,242 from the 2016 net surplus of \$34,607.

Statement of Financial Position

Total assets decreased by \$45,060 from \$218,809. This is represented by a decrease in prepayments and a decrease in cash.

In total, net assets have increased by \$10,365 which represents the net surplus for the year.

Statement of Cash Flow

The cash at end of the financial year has decreased predominantly due to the decline in event income and timing of funding received from DFAT to Indonesia.
